The board discussed what to do about the excess snow days and how to best make these days up. As of Monday February 25; we have had 7 snow days and numerous late starts. This means that currently students have 5 days to make up and teachers have 1 day to add. With Monday June 3rd being the original "last day" of school; Superintendent Brian Corlett suggested that we "forgive" one more snow day thus making Friday June 7th the last day of classes for students and June 10 the last day for teachers. Mr. Corlett acknowledges that the teaches contract reads "teaches should fulfill 181 days" in school; and this proposal leaves them with 179 days. Mr. Corlett is willing to break the contracted rules in the favor of the union in this situation. In an effort to make up days; the teachers are willing to make Good Friday a teacher work day.

It was suggested that March 22, and April 19 be added as student days to give us some "cushion", as the chances of adding more days are quite considerable.

Member Pexa brought a motion to the table to add March 28 & 29 as student days (thus reducing spring break); there was NO second to this motion and it died on the table.

The board agreed that we will proceed with the suggestion of Mr. Corlett knowing that we may need to revisit this subject at the next meeting if we have more school closings.
